Daycare And Vacation Care Policies

Hours of Operation

We take pets 24/7. Unless it is an emergency, we ask that you try and bring your pet before 9 p.m.

Rates

Daycare

\$10.00 per day per pet

Boarding

\$22.00 per night per pet

If your pet eats supplied dog food (I make it myself. Beef/chicken, rice, and vegetables) there will be a \$2.00 charge per meal. You are more than welcome to bring your own food. Please be sure the food is in re-sealable bags or container clearly marked with feeding instructions, and your pet's name.

Transporting to vets, groomers, or pick-up/delivery.....\$5.00
(each way)

Late fees

We don't charge late fees. We do ask if you will be more than 1/2 hour late picking your pet up that you call.

A 24- hour cancellation notice is required or the client must pay a fee to cover the price of reservation

Payments

Payment is due at drop-off for both daycare and vacation care. For now we accept cash or checks. Any additional charges incurred during the stay are due upon pick-up.

Spay/neuter: Home Away from Home advocates responsible pet ownership and the prevention of unwanted pets. In this spirit; we require that pets over the age of 6 months be spayed or neutered to participate in our daycare or vacation care services.

Vaccinations: Pets must be current on all vaccinations. A letter of certification from your vet is required. (Rabies tag is NOT an acceptable form of proof) Pets who fall out of date with their vaccinations after initial acceptance will not be allowed to attend further until brought up to date with submitted documentation.

Fleas and Heartworms: Pets must be on a widely acceptable flea prevention and heartworm prevention program. If fleas or ticks are found on your pet while in the care of Home Away from Home he/she will be given a flea bath at the owners expense. The cost of bath will be \$15.00.

Overall Health: Pets who have been ill or injured in the past 30 days may be required to submit a certification of health or letter of clearance from a veterinarian. Additionally, pets exhibiting signs of distress, restricted movements, labored breathing, or other signs of concern may require veterinary clearance prior to attending.

Please do not bring in your pet if he/she is vomiting, has diarrhea, or otherwise under the weather: After acceptance please advise Home Away from Home of any changes in your pet's health or medication, even if will not be administered here at the facility.

Behavior: Pets must interact with people and other pets in a safe and non-threatening manner. While daycare is an excellent way to socialize your pet, it is not an appropriate place for aggressive or severely under socialized animals. While all pets are screened upon applying for attendance at Home Away from Home, it is impossible to determine an animal's potential reactions to innumerable situations that he/she may encounter in our care.

Home Away from Home reserves the right to refuse or discontinue admittance to any animal we may feel is inappropriate for attendance at our facility. Further at our discretion, Home Away from Home may limit your pet's interaction with other animals and may in other ways limit your pet's activity while in our care if it is necessary to do so for the safety of your pet or other pets in our care. Owners will be notified of any such issues should they arise.

Orientation Day: I would like to have you and your pet to come over and see how he/she reacts with in the playgroup before leaving them for a whole day or vacation care. At that time any paper work can be turned in or filled out.

Daycare and Vacation Care Agreement

_____ I understand that I place my pet/s under the care of Home Away from Home for vacation care, day care, or any other service without liability on the part of Home Away from Home and its staff for loss or damage by or from disease, escape, injury, theft, fire, death, or other unavoidable causes, due diligence and care having been exercised. Home Away from Home and its staff will not be held liable for injury or damage to persons, other pets or property caused by pets in its care.

_____ While all pets participating in daycare or vacation care at Home Away from Home are up-to-date on vaccinations, there are viruses with different strains that cannot be fully vaccinated against. Canine cough and other ailments can be contracted anytime a dog comes into contact with another dog. I agree not to hold Home Away from Home and its staff liable for the contraction of any such illness during my pet's stay.

_____ I authorize Home Away from Home and its staff to allow my pet/s to interact with other pets at the facility. I understand that, although all pets are evaluated for temperament and personality, and Home Away from Home staff supervises playtimes, my pet/s may become injured during interaction and play with other pets. I agree to hold Home Away from Home and its staff harmless for damages resulting from such injuries.

_____ I authorize Home Away from Home and its staff to walk my pet, with other dogs in the neighborhood. I understand that my pet will be kept on a lease using a martingale type harness during any outdoor walks. I release Home Away from Home and its staff from liability for any damages caused by other persons, stray animals, or forces of nature on such walks.

_____ All pets staying at Home Away from Home day and vacation care facility will be checked for flea infestation. I understand that if fleas and/or ticks are found on my pet/s he/she will be given a flea bath at my expense (\$15). While every effort is made to maintain a flea-free environment, I will not hold Home Away from Home and its staff liable for occasional occurrence of fleas.

Should my pet require medical attention for illness or injury while in the care of Home Away from Home and its staff, I authorize Home Away from Home and its staff to provide emergency medical care and to transport my pet to a licensed veterinarian of its choosing for treatment. I agree to reimburse Home Away from Home upon pick-up of my pet/s for any cost incurred in such an event. While Home Away from Home and its staff will make every effort to secure necessary care in an emergency, I will not hold Home Away from Home and its staff liable if unforeseen circumstances make it impossible for them to do so.

If I leave a toy or personal item with my pet while boarding or during daycare, I understand that the item may not be returned in the same condition as it was when it was

left. I will not hold Home Away from Home or it's staff responsible for damage to such items.
